DID YOU INVITE A POTENTIAL MEMBER TO THE MEETING THIS WEEK?

REVIEW:

It's a New Year and time for a fresh start. Let's review our responsibilities as members of the TVEA and to each other as business associates. This is good info. that some of you have probably not read in a very long while, so please review.

Classification Presentation: Let the membership know who you are: your personal background, your business background, what you do and what products and services you offer. Tell a story about your business, and keep members up to date about your business to assure proper representation.

Spotlight: Give a 2-3 minute “commercial” for the **business** (not the person) in the Spotlight by visiting and getting to know more about that **business**.

Road Show: Have an “open house” at your business in lieu of the morning meeting. Make the arrangements to provide breakfast, reimbursed up to \$350 by the Association.

MEETING POLICIES

- Meetings begin promptly at 7:15am.
- \$1.00 fine for being late (coming in after the gavel starts the meeting).
- \$1.00 fine for leaving a meeting early.
- \$1.00 for having no “good” lead.
- \$2.00 for cell phone ringing
- \$2.00 for a missed meeting; discounted to \$1.00 if the Executive Director is notified.
- \$10.00 for no-show as a greeter.
- Greeter Responsibilities:
 - Be at the meeting by 6:45am.
 - Give members their name tags and greet them.
 - Be aware of any guests, make them feel welcome and give them a “guest” name tag.
 - Sell raffle tickets.
 - Greeters’ responsibilities are over promptly at 7:15am.
- 50-50 Raffle Procedure:
 - Raffle tickets are \$1.00 each or 6 for \$5.00.
 - Each game begins with 13 marbles in the bag.
 - If you hold the winning ticket, you get to choose a marble.
 - There are 10 white marbles worth \$5 each, 2 blue worth \$10 each and 1 red marble = winner takes all. 50% of the

cash from the sale of raffle tickets gets added to the cash prize (each game starts with \$50) until the red marble is chosen.

- The other 50% collected goes into the TVEA savings account.
 - Procedure for Bringing a New Guest:
 - Call the office to let the Executive Director know that you will have a guest and the classification of the business.
 - Fines are *waived* for that meeting and you receive *1 free raffle ticket* for bringing a prospective member!
 - Be there to greet your guest and make them feel welcome.
 - You will be asked to introduce your guest; guests are asked to say a few words about their business.
 - Potential members are invited to attend two meetings as guests of the TVEA.
 - Fill out a proposed membership form and give it to the Executive Director.
